3. 2017 minutes accepted. Proposed by Chris Davies, seconded by Tony Keech.
4. **Matters arising:** None.
5. **Chair's report:** The NNAS continues to go through a period of change to enable it to both broaden its catchment but also to improve the quality and consistency of delivery. We are aware of the need to retain 2 years of running costs, and so development has to be undertaken cautiously. The Board has been working hard and excellent progress has been made, with sub-groups working on a variety of tasks to make good progress.

The main projects tackled include:

- Admin has settled well into its own office and there is now a second part-time person in the office, Diane Hoggan, so that we are able to provide a 9-5 service throughout more of the year, and also to ensure continuity of the admin service. I feel that the new arrangement is much more sustainable.
- The Tahdah management system continues to have some issues, however, the Board are convinced that it is a system worth continuing with and expect the issues will become less with perseverance. But all that is under constant review.
- The online shop is becoming well established and now includes branded clothing.
- Meetings have taken place with representatives of SCQF and it is hoped to make progress over the winter towards getting the Silver and Gold Navigator levels accredited with them.
- The book 'Teaching Navigation' by Nigel Williams has been published and is the text that goes with delivery of the Tutor Awards.
- We now have the final draft of the new Outdoor Discovery Award manual. After some final tinkering, it should be in print early next year.
- NNAS took a stand at the annual Outdoor Trade Show in the summer and we hope to repeat that in 2019.
- The NNAS exhibited at the Ten Tors event that took place recently and a lot of good contacts were made.
- We have set up a closed Facebook group for NNAS providers (Ian Stewart has taken on moderation of this) and a summary is as follows:  
There are 102 people on the forum.  
We have had a variety of posts from members sharing items of general interest - dodgy compasses, interesting map features and useful skills checklists.  
Questions have then been about: AALA restrictions, Lower age limits for awards, running courses over multiple short sessions, lots of Tahdah queries, some general 'how to' type questions, mostly answered quickly by board members, but some help from other providers, and a question about the possibility of posting certificates direct to candidates.  
May I remind you that, if your query or comment is to do with Tahdah or administration, your first point of contact is the office.
- Our Technical Advisor, James Woodhouse has been very busy and will give his report shortly.

6. **Admin report:** NNAS is a Charity and Company Limited by Guarantee. Being a small charity necessitates a Report of Accounts by a suitably qualified charity accountant. Haines Watts recently acquired Atkinson & Co. of Tillicoultry and has been nominated by the Directors to be the NNAS accountant and as such has produced a Report of Accounts. The report was a little later than usual coming from the Accountant but was accepted by the Directors at yesterday's Board meeting, where it was signed. Unsigned copies are here for the AGM. After the AGM the signed Report of accounts will be circulated to Providers and a link will be put on the NNAS website.

Jane Howie provides admin support services for NNAS on a part time basis between 9am and 2.30pm. Diane Hoggan recently joined the admin team and works from the office between 2pm and 4.45pm. Diane is quickly getting up to speed with all things NNAS and she is settling in well into her new role.

**Current registrations:** There are currently 328 individual Providers throughout the country. This is on a par with last year. Corporate memberships are held by: Lowland Rescue, Air Cadets, Army Cadets and SkillForce.

The office has two banners that can be borrowed by Providers for events, conferences etc. Please contact the office in good time if you would like a banner for an event. We also have a stock of NNAS leaflets if providers would find them useful. These are free of charge, if you require more please contact the office.

**Treasurer's report:** The accounts presented relate to the year to 30<sup>th</sup> April 2018. This year there was a surplus and this is put towards furthering the ongoing projects. NNAS needs to keep at least two years running costs in reserve. The NNAS is doing ok and currently keeping steady.
